## 1. Background

Al-Hayat Center - RASED, in cooperation with Plan International Jordan, is implementing the project "Jordanian Youth Actively Improving Human Rights and the Electoral Process in Jordan." This initiative aims to enhance youth engagement in human rights advocacy and electoral processes in Jordan. One of the key components of this project is capacity-building on the Universal Periodic Review (UPR) mechanism to equip youth with the knowledge and skills to participate effectively in the human rights review process.

To achieve this, Al-Hayat Center - RASED seeks to recruit a qualified expert to deliver a **2-day training on UPR** for youth participants. The training will focus on building their understanding of the UPR process, Jordan's commitments and obligations under international human rights mechanisms, and practical ways to engage in UPR advocacy.

# 2. Objective of the Training

The primary objective of the training is to empower youth participants with:

- A clear understanding of the Universal Periodic Review (UPR) and its significance in human rights advocacy.
- Knowledge of Jordan's past UPR cycles, commitments, and recommendations.

- Strategies for monitoring and reporting on human rights issues in Jordan within the UPR framework.
- Techniques for drafting shadow reports and conducting advocacy campaigns related to UPR recommendations.

### 3. Scope of Work

The selected expert will be responsible for:

- 1. Developing a Training Module
  - Preparing training materials and presentations tailored to the Jordanian context.
  - Developing interactive exercises, case studies, and group discussions to enhance learning.
- 2. Conducting the Training
  - Delivering a **2-day training** (25-26 July 2024) to a group of youth participants.
  - Ensuring an engaging and participatory training approach.
- 3. Providing Training Documentation
  - Submitting a training report summarizing key topics covered, participant engagement, and recommendations for follow-up.
  - Providing a post-training evaluation summary.

### 4. Deliverables

The expert is expected to deliver:

- 1. A detailed training agenda and methodology prior to the training.
- 2. Training materials (presentations, handouts, case studies, exercises, etc.).
- 3. A pre-and post-training assessment to evaluate knowledge gain.
- 4. A **final training report**, including participant feedback and recommendations for future capacity-building efforts.

- Experience in **youth capacity building** and engagement in human rights advocacy.
- Excellent facilitation skills and ability to deliver interactive training sessions.
- Fluency in Arabic and English (spoken and written).
